Anonymity in the rooms of Al-Anon was key to help me build trust and my self-esteem. The principle has grown to become the basis of principles over personalities and humility. It is a challenge to remove my EGO and to let my higher power lead my interactions with others and my thoughts. Practicing the principle of anonymity helps me stay in the present and not the past or future.

Public Outreach Reminder

Received recently from Vali Fayen, Executive Director, WSO:

"We are all messengers of Al-Anon's purpose and have the responsibility to accurately communicate it to avoid confusion, misperception, or dilution of our program.

The 2018 Membership Survey states "35% of the members came specifically because of someone's use of drugs." The survey also showed that 78% of these members eventually came to realize that someone else's drinking also effected their lives.

When developing and implementing Public Outreach activities, members are urged to keep Al-Anon's Twelve Traditions in mind, this includes reviewing the words of the Traditions in their entirety. This summary of applicable Traditions may assist your communication efforts with members, newcomers, professionals, and the media.

- Tradition Three states "The only requirement for Al-Anon Membership is that there be a problem of alcoholism in a relative or friend."
- Tradition Four tells us that "Each group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole."
- Tradition Five defines that our singleness of purpose is to help families of alcoholics.
- Tradition Ten tells us that "The Al-Anon Family Groups has no opinion on outside issues; ..."

According to a statement on page 131 in Al-Anon's Conference Approved Digest of Al-Anon and Alateen Policy "... our responsibility is to ensure Al-Anon's survival as a resource for families and friends of alcoholics. By focusing on these drug-related problems, we risk being diverted from Al-Anon's primary aim."

Therefore, conveying that Al-Anon is for families and friends of alcoholics and drug addicts in local or Area produced Public Outreach materials is an expansion and misrepresentation of Al-Anon's purpose (see Tradition Five). This includes but is not limited to posters, flyers, websites, etc.

We appreciate your efforts supporting the families and friends of alcoholics and maintaining our Traditions and primary purpose."

Literature Committee

The Literature Committee is gathering information regarding <u>The Dilemma of the Alcoholic</u> <u>Marriage</u>. The five options we are considering now are:

Option 1: Archive/discontinue the book altogether.

Option 2: Keep printing the book exactly as it is.

Option 3: Include a new preface for the book, but otherwise keep it as it is.

Option 4: Rewrite the entire book.

Option 5: Print the current book with a new preface as a "Classic" edition AND print a booklet that includes "gems" from this book, with possibly some new material.

We have been asked to voice our thoughts on the Pros and Cons of each option. We will be discussing these at the September Literature Committee meeting.

Tennessee Area 52 Criteria to be Referred and Do Not Refer Process

Per the World Service Office's request, the Tennessee Area's Do Not Refer Process and Criteria to be Referred were both submitted for review by WSO last September. We finally have a response from WSO, with some clear direction on what we need to do to.

- 1. Bullet II we need to clarify that the District and/or Al-Anon Information Service Liaision is participating in the Task Force researching the concern. This can be that the DR or AIS Rep is a member of the Task Force or only that they are invited to provide input to the Task Force as a matter of Area autonomy. This is implied in this bullet point, but WSO would like us to clarify that. It has been the Area's practice in these matters to include the DR and/or the AIS Liaision in the research.
- 2. Bullet V WSO is looking for a more comprehensive resolution process to bring these groups back into compliance so they can once again be displayed on meeting lists. The letter described in this bullet represents an initial step toward resolution, but WSO would like to see a more in-depth acknowledgment of the Area's ongoing responsibility and commitment to working proactively with the groups. The Area's practice has been to welcome these groups to participate at AWSC and at Assembly, although they have chosen not to at this point. The groups receive The Traveler, if they have a GR, and the DR is included on the e-tree for Area information.

The development and approval of the Tennessee Meeting List Publishing Policy is a matter of Area autonomy. The WSO would only require the changes identified above if the Area wishes to have WSO's support in removing the meetings from publication in the WSO meeting list.

I have not had a conversation with WSO about these yet, but plan to do that after our Convention.
