# The Board of Trustees

Concept Six describes how the World Service Conference (WSC) has entrusted administrative authority and responsibility for Al-Anon Family Group Headquarters, Inc. to our Board. This responsibility carries with it a critical need for the availability of strong, dedicated leadership by our Trustees.

"The Board of Trustees, which meets quarterly, is the legal entity responsible for operational oversight of Al-Anon's funds and services." 2022-2025 Al-Anon/Alateen Service Manual pg. 69

The Board of Trustees is composed of seven to 21 volunteer members: one sustaining member (the Executive Director), Trustees at Large, and Regional Trustees. Our co-founders Lois W. and Anne B., now deceased, were honorary lifetime members. 2022-2025 Al-Anon/Alateen Service Manual pg

The Word Service Office is composed of executives, staff members and selected committees supervised by the legally empowered Board of Trustees and its Executive Committee. 2022-2025 Al-Anon/Alateen Service Manual pg. 84

## **Current Trustee Vacancies**

There are theses vacancies:

- Two Trustees-at-Large
- Three Regional Trustees US Northeast US Northwest

## **US Southeast**

It is my hope that further discussion here, will demystify the positions of Trustee and be an encouragement for members in Tennessee to send in resumes for the Southeast Regional Trustee or a Regional Trustee.

## Trustee Nominating Process

After discussion at the previous WSC, the Trustee application process will become a skills based approach beginning 2023. The new Trustee role description will be put into use beginning with the 2023 Nominating Process. The role description will be posted to al-anon.org after the August 15, 2022 deadline for submitting a Trustee resume to avoid confusion about what to submit for the 2022 Nominating Process, which is already underway.

## New Resume Submission Deadline

The Board decided to include a short interview conducted by the members of the Nominating Committee for Trustee-at-Large candidates. The new date of November 15 allows time for those interviews to happen before making recommendations to the Board of Trustees in January.

## **Trustee Service Requirements**

Trustees

- Are an active member of Al-Anon Family groups, with at least ten (10) year of continuous membership
- Are eligible to become an Al-Anon Member Involved in Alateen Service (AMIAS) & pass a national background check
- Have service experience beyond the group level
- Are not a present or past member of Alcoholics Anonymous (A.A.)
- Are able to speak and write proficiently in the English language

Please note there is no requirement one must have service experience as a Delegate!

Nancy Shore, South Central Regional Trustee, will attend via Zoom to share of her experiences as Trustee and her knowledge of the position and the resume process.

*All are welcome to attend our Assembly*. Please encourage everyone to attend, and please remind everyone Group Representatives have voice and vote. Visitors listen and observe.

In preparation for her visit, during phone conversations with Nancy Shore, she answered some questions I had about Trustees.

## Is there a difference between Regional Trustees and Trustees-at-Large?

No. They are all volunteers and serve without distinction. *Trustees are Al-Anon members*.

We have regional trustees to give a broader base of experience among the Trustees. If the majority of trustees were from the east, would the Board gain an understanding of experiences from the regions in the west and the central part of the US? What about experiences from all of Canada?

### Are trustees part of the links of service?

No. The Board of Trustees is a legal entity. The Links of Service provide communication between the World Service Office and the groups via our service arms.

## How many committees can a trustee be on?

### What committees are not listed in the Service Manual?

Nancy Shore shared a great deal with me about this. We will hear her answer at Fall Assembly.

#### If we have fewer trustees, does that impact the amount of work for each trustee?

Yes, it can. Trustees area assigned other committees as necessary. After WSC this year, a committee was established to look at comments and concerns brought up during the Conference.

## e-Book Update

The Finance Committee recommended, and the Board of Trustees approved, that the remaining Conference Approved Literature (CAL) currently sold as printed books also be offered as eBooks. In August, World Service Office Staff will begin the work required to move forward with this approved recommendation. The work may take a while.

## **Financial Reports**

The 2021 Financial Report and the Budget were presented at 2022 Spring Assembly. The report is available by accessing

# **Revised Budget**

The Board of Trustees approved the *revised* 2022 Budget. Expenses are being cut but there is still a deficit of \$332,730.

- While we are buying literature a little more than was expected, by \$8,930, the sales still have not returned to pre-pandemic levels.
- Our year-to-date contributions are below what was expected in the budget by \$66,725.

## June, 2022 Update

Contributions:

• Contributions little bit under budget, but have increased because of the Special Appeal letter. The hope is members will continue to contribute at the same level so we can receive the service we expect from the WSO.

• The June Tradition 7 Contributions were 373,444 a result of the special appeal but were still under budget. The hope is the June trend in contributions continues through July.

## Literature

The literature price increase will help. The last increase was 10 years ago.

- Sales from e-Literature are \$99,055.
- Magazines and mobile app sales increased
- The market has not been favorable for our investments.

## Expenses:

• Our expenses at six months are at the level that was expected for the entire year. The increases are because of translation needs and airfare.

## Special Appeal Letter

### June 2022

"This letter is a special appeal to all Al-Anon and Alateen members. While the World Service Conference recently approved the WSO's 2022 annual budget, which projected a -\$353,114 deficit, the deficit is already trending higher than projected, at -\$325,749 as of April 30, 2022. Our contributions and literature sales are not meeting our planned budget."

## Suggested Tradition 7 Contributions Spreadsheet

From Cindy M., AFG Treasurer:

*"With understanding comes unity. With unity comes abundance. With abundance we can reach more friends and families affected by the disease of alcoholism."* 

This spreadsheet is designed to show Districts and Groups suggested Tradition 7 Contributions dependent on the budgeted expenses and the number of groups for each service arm. The number of groups and budgeted expenses for a district would be changed to reflect that district.

In this situation, the total of the Tradition 7 Contributions would be \$916 annually per group. A percentage of this total for each service arm is in the 4<sup>th</sup> column.

\*\*The WSO is unable to give me a current total number of groups. The number is calculated by the total budget divided by the cost per group as provided in the August 2022 WSO Finance Report Update.

## Percentage of a \$150 Total Annual Contribution By a Group

Each group is able to modify the Group Annual Contribution to accurately reflect the group. If a group was able to contribute \$150 annually, by using this table, the group would have a *suggested* amount for each service arm.

# **Experiences Traveling**

# Arriving



Rather than fly to LaGuardia Airport or JFK, I chose to fly to the Westchester Airport in White Plains, NY. Being used to the Nashville International Airport, I found Westchester a much smaller airport with a "slower pace."

I was reminded of much younger days as I walked across the tarmac and climbed the metal stairs that had previously been rolled up to the side of the airplane.
