Explanation

Expenses

The largest categories of expenses consist of WSO Staff salaries and benefits, technology support, Conference costs (including interpretation), and postage. Expenses are less than we expected and income is more than we projected. As a result, the have under budget by \$732,322. We continue to monitor all expenses and reduce them wherever possible.

There is gratitude for the increased contributions and literature/magazine sales! They continue to be more than we expected. The literature sales are more as a result of the new daily reader. The WSO's role to provide services to the fellowship (and outreach to other countries) can only be carried out with consistent contributions, purchase of Conference Approved Literature (CAL), and subscriptions to our Mobile App and our magazines.
